



Transparency notification BlackRock, Inc.

Brussels (Belgium), 10 August 2018 – 20:00 (CEST) – regulated information

1. <u>Summary of the notification</u>

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification from BlackRock, Inc. (having its registered office at 55 East 52nd Street, New York, NY, 10055, U.S.A.), dated 8 August 2018.

BlackRock, Inc. has notified that, following a disposal of UCB shares with voting rights and equivalent financial instruments by its affiliates, its total holding in UCB SA/NV has decreased and has crossed downwards the 5% threshold on 7 August 2018.

On 7 August 2018, BlackRock, Inc. (taking into account the holding of its affiliates) owned 9 035 664 UCB shares with voting rights (versus 9 182 900 shares in its previous notification), representing 4.65% of the total number of shares issued by the company (194 505 658) (versus 4.72% in its previous notification) as well as 625 890 equivalent financial instruments (versus 623 970 in its previous notification) representing 0.32% of the total number of shares issued by the company (same percentage as in its previous notification).

2. <u>Content of the notification</u>
